Hello all,

Early Thursday morning around 3:30 AM myself and a friend saw what seemed to be an act of hazing at Riverwind Apartments off of Alafaya Trail. I was returning from All Knight Study to visit my boyfriend, the incident occurred in the visitors parking space. There were a total of 5 individuals involved in this act. Two of the gentleman were a little over 6 foot in height, the other gentleman were significantly shorter. The individuals were spinning what seemed to be red and white walking canes. The shorter individuals were being beaten with the canes by the two taller individuals after dropping the walking cane. After watching this for about 10 minutes I was unsure if this was hazing or just an act of stupidity. I did not approach the individuals as I should have, but I felt so bad afterward doing nothing. After speaking with my roommate about the incident she informed me these individuals had to be members of the organization Kappa Alpha Psi Fraternity. I then researched the organization on YouTube when I then confirmed that this was the organization due to the spinning of the walking cane. Hazing is a very serious matter that should not be taken lightly. I decided to file this report to prevent this from happening to anyone else. I myself am not involved in a sorority for this exact reason. I hope this report makes a difference.
